American Rescue Plan (ARP/HEERF III) Higher Education Emergency Relief Fund - Emergency Financial Aid Grants to Students

The Higher Education Emergency Relief Fund III (HEERF III) is authorized by the American Rescue Plan (ARP), Public Law 117-2, signed into law on March 11, 2021, providing \$39.6 billion in support to institutions of higher education to serve students and ensure learning continues during the COVID-19 pandemic.

ARP funds are in addition to funds authorized by the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), Public Law 116-260 and the Coronavirus Aid, Recovery, and Economic Security (CARES) Act, Public Law 116-136. Emergency funds available to institutions and their students under all emergency funds total \$76.2 billion

Certification and Agreement Acknowledgement:

HEERF I - Hesston College acknowledges that a signed Certification and Agreement was submitted to the Department of Education on April 14, 2020 for HEERF I grant funding. This agreement indicated our commitment and assurance that Hesston College would use no less than 50% of the funds received under Section 18004(a)(1) (HEERF I) of the CARES Act to provide Emergency Financial Aid Grants to students.

HEERF III (ARP) - Section 2003(7) of the ARP requires Recipient, an institution of higher education as defined in section 101 or 102(c) of the Higher Education Act of 1965, as amended (HEA), 20 USC § 1001 or 1002(c), to provide emergency financial aid grants to students in an amount equivalent to the sum of two amounts: 50 percent of the portion of its allocation that is based on formula factors from CRRSAA section 314(a)(1)(A)-(D) and 100 percent of the portion of its allocation that is based on formula factors from CRRSAA section 314(a)(1)(A)-(D). The amount of funds made available by this supplemental award under Assistance Listing Number (ALN) 84.425E represents the minimum amount that Recipient must use for making emergency financial aid grants to students.

Funds Received per the ARP HEERF Grant:

Hesston College received a total of \$575,799 for the Higher Education Emergency Relief Funds for students grants. The funds were received on May 13, 2021.

Distributed Grants:

As of March 31, 2022, all \$575,799 of the HEERF student grants have been distributed to students. In the fall of 2021, \$287,900 was distributed as reported earlier and in the spring of 2022, \$287,899 was distributed. This report will provide details on the spring distribution.

Student Eligibility:

In the spring of 2022, a total of 300 students at Hesston College were eligible to participate in the program under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants.

Grants Awarded:

All 300 students eligible to receive an Emergency Financial Aid Grant received a grant.

Distribution Methodology:

It was determined that two separate grant distributions would be awarded, one in the fall semester and one in the spring semester, each distribution using half of the total allocated HEERF III funds.

To Determine the distribution method for the HEERF III Grants, the same formula was used that was developed and used for the distribution of HEERF I grants. For the HEERF I grants, a team of 6 Hesston College Faculty and Staff members was created. The team determined that all students should receive grant funding as all students were impacted financially in some way from the disruption of campus operations related to COVID-19. To determine grant amounts distributed, a formula was selected to address two factors, part-time and full-time status as well as a need based analysis according to a completed FAFSA or other financial data points. Below is the formula that was created and used to identify student grant disbursement amounts.

On March 11, 2021 Congress passed the American Rescue Plan (ARP). This act allocates funding to higher education institutions for the purpose of providing Higher Education Emergency Relief Fund III (HEERF III) Grants to eligible students. Hesston College has been allocated \$575,799 to provide eligible students with emergency student aid which can be used for any portion of a student's cost of attendance (e.g., tuition and fees, room and board, cost of books, supplies, transportation), or for emergency costs that arise due to coronavirus, such as tuition, food, housing, health care (including mental health care) or child care.

Hesston College is awarding HEERF III grants in two parts, one distribution occurred this past fall and one distribution will occur the week of March 28 – April 1.

• To qualify for a fall grant, a student had to be enrolled (degree-seeking) at least half-time on September 30, 2021 and be residing within the USA.

• To qualify for a spring grant, a student had to be enrolled (degree-seeking) at least half-time on February 28, 2022 and be residing within the USA. *Please note that allocations in the spring may differ depending on student counts and any changes to enrollment status.*

To determine grant amounts distributed, a formula was used to address two factors, part-time and full-time status as well as a data informed need-based analysis.

The Student Emergency Relief Grant that has been allocated to you can be distributed in three ways. 
